An extensive amount of time has been put into rewriting the entire By-Law into a new document to try and clean it up and correct some minor errors. This will hopefully make it easier to revise going forward as it is a fresh, clean, new document. I will be working closely with all Directors over the next couple of months to revise Schedule "CC" for proposed 2025 By-Law changes.

Section 6. Course Registration Fees have been changed into charts. Below in red is the previous By-Law and the charts are the changes to the 2024 By-Law.
